- What is at the heart of my desire to serve again on the Animal Services Committee is my commitment to improve the quality and humanity of the city's animal services and animal shelter.
- A year ago, the Costa Mesa Animal Shelter was fraught with problems. Now, the City has contracted with Dr. Rizk at Newport Center Animal Hospital and Priceless Pets, to provide a well-managed and humane intake for stray and relinquished pets and a no-kill rescue to take Costa Mesa's adoptable animals and find them homes.


