Dear Costa Mesa Cannabis Ad Hoc Committee and City Staff,

As an owner and partner in Se7enLeaf, I wanted to personally thank you for including me and the Se7enLeaf organization in the discussions over the last few weeks to help organize a ballot measure that will allow for retail cannabis businesses in Costa Mesa. I am proud to have worked closely with the Ad Hoc Committee and City Staff on this initiative and I believe the City has produced a ballot measure that is both advantageous to the residents of Costa Mesa and any qualified cannabis operators that would like to establish a retail business within the City.

As a current operator in Costa Mesa, this ballot measure, if passed, will help our manufacturing and distribution business by creating more legal retail outlets for our customer's products. By having more legal retail outlets, legal cannabis businesses and the City of Costa Mesa will be better equipped to combat any illicit dispensaries currently operating within the City and ensure that residents have access to safe, clean, tested product. Additionally, that City will benefit by establishing another tax revenue stream that can be used to help fund improvements within the community.

The only requested adjustment to the ballot measure that Se7enLeaf has at this time is that the distance from sensitive uses for retail storefronts be an up to 1000 feet (but not less than 600 feet, per State law), in order to give the ability for the City to allow for future modification should the lack of viable property locations become a problem for interested operators.

I personally spent this weekend visiting potential retail properties throughout the City and can share with you that the 1000-foot distance requirement poses some real challenges, as commercially zoned real estate that is viable for a retail cannabis business is extremely limited with this requirement, and a reduction to perhaps 700 feet would make a significant difference and allow for more properties to be adequately zoned in.



With that said, Se7enLeaf supports the November 2020 Ballot Measure to include Retail Cannabis Businesses in Costa Mesa and we are humbly asking all Council Members for their vote this evening.

Thank you again for including us in this process and we look forward to our future meetings with the Ad Hoc Committee and City Staff.
