Having served on the ASC from its inception, I bring a historical/institutional understanding of the Committee's original mission in addition to the knowledge base I was brought on for initially. Primarily, I want to see our CM Animal Shelter (Priceless Pets) continue as long as they are doing the good work for our City and our animal population. As with any Committee appointment, I hope to be selected on the basis of what I have accomplished on the ASC thus far and what it is believed I am able to accomplish over the coming Term. In lieu of a resume, I will briefly list my qualifications and explain their relevance. I am a retired (licensed) veterinarian which allows me to understand the medical, behavioral, and structural (housing, caging, handling, laws, etc.) needs required by animals. I was in private practice where I treated dogs, cats, exotics (rabbits, rodents, birds, reptiles, amphibians), and wildlife.
